



Safety

Sailors must at all times keep clear of commercial shipping.

Adequate personal buoyancy must be worn at all times when afloat. Wet or dry suits are not considered adequate buoyancy.

It is the responsibility of each boat owner to make sure that their boat is seaworthy, that she complies with her class rules, and that she is covered by third party insurance to a minimum of £1,000,000. Evidence of insurance and compliance with class rules may be demanded by the Sailing Secretary at any time.

Each dinghy shall carry a paddle. Each Mirror dinghy shall also carry an anchor, minimum weight 1.5kg (3.3lb), with at least 20m (60') of suitable line attached.
